The postal ballot, if required, will open at 9am ACST on Monday 3 September 2018 and close at 5pm ACST on Monday 24 September 2018.

Attendance ballots, if required, will held on **Thursday 20 September 2018** between 7am and 4:30pm ACST for all offices where members within the Tram and Bus Division have an entitlement to vote. These will be advertised separately at each workplace.
